<u>General Responsibilities</u>: At the direction of the Energy Coordinator and/or Housing Coordinator, performs assessment of combustion appliances/heating units and A/C units including testing and documentation to prepare time, cost and labor estimates for products, services, and installs measures appropriately to ensure customer health and safety.

Specific Duties and Responsibilities:

- Will know and apply Standard Work Specifications (SWS) and the NFPA. Has ability to refer to the SWS and NFPA in reference to questions of work to be performed, analyze the facts and make decisions based on the individual job and the SWS and other referenced codes.
- Performs initial safety inspection of the heating and other combustion appliances if the Inspector/Estimator has not completed it.
- Is able to complete a Manual J to determine proper sizing of the heating unit replacement if not completed by the Inspector/Estimator.
- Install heating units, water heaters, A/C units, roof jacks, vents and thermostats as per the manufacturer's instructions and the SWS and other referenced codes.
- Is able to inspect, trouble shoot and resolve the problem for inoperative heating units, water heaters and A/C units.
- Responsible for correct accurate completion of all paperwork required on furnace jobs including Requisitions, Returns, Time Sheets with correct job numbers, and complete final test numbers on all combustion appliances.
- Portrays a neat, professional appearance. Is able to dress according to the weather condition and jobs assigned while remaining neat, clean and well groomed. ACCAA will provide a uniform that is expected to be worn daily.
- Cleans assigned workspace and vehicles of debris. Pick up and properly puts away supplies and equipment.
- Completes all tasks as assigned.
