SKILLS AND QUALIFICATIONS:

- Ability to demonstrate proficiency in performing light homemaking tasks.
- Must be able to communicate effectively.
- Confidentiality in all aspects of program operation must be maintained.
- Must be able to follow both verbal and written directions and have the ability to work as a team member.
- Must be able to travel to any of the designated locations, inside and outside the area. Valid driver's license and automobile insurance required. Driving record must meet Agency standards.
- Must agree to a review by the Ohio Bureau of Criminal Investigations, understanding that certain convictions may result in termination of employment.
- Position requires ability to bend, climb stairs and lift up to fifty pounds.
