#### **JOB DESCRIPTION**

Job Title: Inspector / Energy Auditor

**Supervisor:** Energy Coordinator / QCI Manager

**Status:** Regular / Full-Time

<u>GENERAL RESPONSIBILITES:</u> Under the direction of the Supervisor, performs initial inspections of homes / mobile homes to assess work to be performed in accordance with program and funding guidelines. Perform Crew Leader functions as required to meet production.

#### **SPECIFIC DUTIES AND RESPONSIBILITIES:**

- Thoroughly understands and is able to implement the Weatherization Field Guide.
- Keeps current with all program changes and updates by attending conferences, meetings and reading all Information Memorandums.
- Responsible for ensuring all Agency Policy and Procedures are followed including but not limited to Personnel, job safety, customer safety and satisfaction, driving safety, etc.
- Responsible for the inspection of the client's home in accordance with the (SWS) Standard Work Specifications.
  - o Inspection of overall building shell / exterior / assess walls, roof, windows, doors, chimney / flue pipes, gutters, existing insulation and general drainage
  - Inspection of overall building shell / interior foundation information, attic condition, interior walls, wiring integrity, moisture damage, thermal bypasses, existing insulation, health hazards, and structural integrity
  - Performs initial safety inspection of all combustion appliances, completes all required testing and documents test results completed in the Data Collection Form. Installs all required safety equipment such as Carbon Monoxide Detectors.
- Must have superior knowledge of the use of all diagnostic equipment and related methods used to perform an accurate and complete analysis of the homes combustion appliances.

- Analyzes weatherization work and determines procedures, quantity, type of materials along with the approximate duration to complete the process.
- Provides consumer energy education.
- Responsible for accurate completion of all paperwork required, written legibly with detailed instruction to allow the Weatherization Crew Leader to follow and guide his/her crew to complete the job.
   Includes Data Collection Forms, Requisitions, returns, blue books, reporting forms and client/agency records.
- Must document any health hazards, any needed special preparation and/or tools (communicates
  problems with customer, "wasps", "mean dog", "customer must clean up, clean out or fix before we
  can begin work"...)
- Provides training and technical assistance to field staff when needed and is available to provide additional information to aid in the completion of the job.
- Performs final inspection of homes in accordance with SWS and BPI, signs off on completed jobs.
- Travels as necessary for attendance at workshops, meetings, seminars and trainings for fulfillment of regulations.
- Abides by all agency rules and regulations.
- Portrays a neat, professional appearance. Is able to dress according to weather conditions and job assigned while remaining neat, clean and well groomed.
